Next Year in Peace and Wholeness

We keep saying that we are living in “strange times” – having used the adjective “unprecedented” so many times recently that one is reluctant to pronounce it anymore. I can hear Inigo Montoya, played by Mandy Patinkin, in *The Princess Bride* commenting to his criminal boss, Vizzini (Wally Shawn), who keeps using the word “inconceivable!”: “You keep-a using that-a word...I don’t-a think it means what you think it means!”

Why did Inigo say this? Because all of the things that Vizzini thought were “inconceivable” kept happening. And with us, too, the “unprecedented” has been happening so frequently that one would almost think it means something like “Oh, *this* again!”

Who would have thought last March as we were celebrating Purim (just starting to be extra-careful about wiping things down and not giving one another hugs or kisses), that six months later we would be coming back together for the first time (in a much attenuated form), holding High Holiday services to a sparse, well-spaced live congregation wearing masks in our sanctuary, with some fifty others watching online? Who would have thought that the Israeli government would order its second lockdown to begin on Erev Rosh Hashana, so that Israeli Jews could not experience even this amount of “normality” (although, of course, it is more important that they stem the rising infection rates) – or that thousands of Jews on the West Coast, or along the Gulf Coast, would experience their holidays with their lives in mortal danger from flooding or fires?

Strange times indeed. Never had the list of life-threatening dangers in the prayer *U’netana Tokef* seemed so possible as phenomena that might actually happen to us in this day and age:

*...who shall live out the limit of their days,
and who shall not; who shall perish by fire and
who by water...who by hunger and who by thirst,
who by earthquake and who by plague...who shall
rest and who shall wander, who shall be at peace
and who shall be tormented...*

Now I don’t believe that God “decrees” these things for any of us; but I *do* believe that, as our liturgy proclaims, the *human* actions of *t’shuvah* (changing our ways), *t’fillah* (attention to our spiritual life) and *tz’dakah* (doing justice and being charitable) *can* avert some of these potential disasters.

By the time you get this October bulletin, we will most likely be well into the week of *Sukkot*. Sadly, we will not be able to “dwell in booths” together this year, but even if you cannot build a home-sukkah yourself, I urge you to build a *virtual* sukkah in your imagination: imagine yourself sitting outdoors, between a sukkah’s fragile walls, hearing the *skakh*, the leafy-branch roof-covering rustling in the breeze, with patches of sunlight playing through it onto the table, and think for a moment of all of the generations of Jews who wandered...through the desert after their escape from Egypt; through all of our many places of wandering after both the Babylonian Exile and the exile forced upon us by Rome. Our existence is all-too fragile, and yet, like the taste of challah, apples and honey in a sukkah on a sunny early autumn day during *Sukkot*, shared with family or friends, it is also sweet.

As I write these words, I don’t yet know what our *Simchat Torah* will be like this year – except that it will not be “traditional.” But I hope that you will try to join us on our *Simchat Torah* Zoom service. We will share words of Torah, we will sing songs of *simchah* (joy), because, even if joy is not what we are feeling, *song* can help reactivate this spiritual well within us, at least for the time that we are together – in whatever way we can *be* together.

I want to thank everyone who helped make our High Holy Days go as well as they did under such circumstances and all who attended either in person or online. We *are* holding one another up as a community during this strange, difficult time. At the end of Yom Kippur we sing:

L’shanah ha-ba biY’rushalayim – Next year in Jerusalem!

Well, I doubt that we will all literally see one another next year in *Yerushalayim*, but may we all celebrate together next year at Temple Beth El in peace (*shalom*) and in wholeness (*shleimut*).

PRESIDENT'S MESSAGE

As we begin a new year I want to reflect about the past six months. Just after Purim the world changed, and within days we decided to close the Temple and wait out the Coronavirus. We canceled Passover, even though it seemed miles away. Rabbi Mark then led the way in utilizing Zoom, not only as a way for our members to participate in services from the safety of their homes, but also for board and committee meetings. One great aspect of Zoom is that it has allowed our members living near and far (including several in their 90's) to participate in our services and meetings on a regular basis. We may have to figure out how to continue to stream our services once our doors are open again so that people from all over can continue to participate, but I am afraid that is still a ways down the road as we once again hunker down and wait until it is safe to gather together once more.

After seeing the results of the High Holiday survey, the board agreed that we really should try our best to offer in-person services for the High Holidays, provided we could do it safely. After several meetings and much planning, we were able to invite those who reserved a seat to come and enjoy the services in our beautiful sanctuary, while also offering live-streaming via Zoom for those who were unable to attend or simply preferred to watch from home.

I am delighted to report that everything went remarkably to plan. Everyone who came to the Temple was happy to comply with our requests, all of which were safety-driven. Everyone wore their masks, confirmed that they were healthy, had their temperature taken and chose socially distanced seats. We had extra help on hand, as well as several board members to help with the check-in process. Rabbi Mark and Cantor Shoshana did a fabulous job of paring down the services to two hours or less while keeping them meaningful and spiritual, and the live-streaming went so well that several of our out-of-town members called to say how much it meant to them to be able to be a part of our services from afar. Being able to offer something to everyone for our High Holidays was extremely important to us, and I hope you agree that we did our best to make that happen.

We could not have done it without the leadership of the board, with special thanks to Rick Schwartz, Dan Schafner and Ken Littman for helping with the check-in process. Rick also helped secure many of the supplies and helped design the new procedures. Rabbi Mark and Cantor Shoshana spent countless hours working to keep the services to two hours, and they pulled it off in fine fashion. Marie Twomey has been invaluable, making sure we had everything we needed to open safely, and drawing up many of

the new procedures from scratch. George Haire has been diligent about being here to open, close, receive flower deliveries and make sure the building was ready, all despite feeling lousy as he fights the battle of his life against cancer. We were also very fortunate to hire Henry Parker, who coordinated with George and Marie to really get the building into shape before the High Holidays, and he did a fantastic job. Thanks, too, to Arleen Bor, who once again stepped up to help wherever we needed her. Thanks again to Andy Polin for donating the equipment for the live-streaming, and to the techs who filmed the services and made sure everything worked flawlessly. Thank you to Elaine Weiss Reback and Sisterhood for taking care of the flowers, which were gorgeous and perfect for this year. Thank you to all who made last-minute donations to the Flower Fund. Thank you to Cantor Shoshana and Elaine for delivering prayer books to our local members. Thank you to everyone who came to services and followed all of our safety regulations. If I missed anyone, please forgive me. We have often said, "it takes a village," but never has it been more applicable than this year.

It is in times like these, when we all come together to make the best of the current circumstances, that I am very humbled to be a part of this warm and wonderful community. Please stay safe and healthy, and let us know if we can help.
